RESOLUTION NO. 2026-03**

**A RESOLUTION OF THE TOWN OF LAKE CITY BOARD OF
TRUSTEES AUTHORIZING THE HINSDALE COUNTY SHERIFF TO
ENFORCE STATE AND COUNTY LAWS WITHIN THE TOWN LIMITS**

WHEREAS, the Board of Trustees of the Town of Lake City, Colorado (the “Board”), pursuant to Colorado statute, is vested with the authority of administering the affairs of the Town of Lake City, Colorado (the “Town”); and

WHEREAS, the Town is a municipal corporation that has been duly established and is operating pursuant to Colorado Constitution Art. XIV and XV and Title 31, of the Colorado Revised Statutes (“C.R.S.”); and

WHEREAS, Hinsdale County (the “County”) is a county of the State of Colorado that has been duly established and is operating pursuant to Colorado Constitution Art. XIV and Title 30, C.R.S.; and

WHEREAS, the County Sheriff is an elected official of the County; and

WHEREAS, the Town and the County have historically entered into an Intergovernmental Agreement for the County Sheriff to provide police services to the Town pursuant to C.R.S. § 30-11-410(1); and

WHEREAS, C.R.S. §§ 30-15-401(1)(h), 30-15-401(2)(a)(I), and 30-15-401(8) permit the Town to consent to the application of certain County laws and all state statutes within the incorporated municipal boundaries of the Town; and

WHEREAS, the Board desires to hereby expressly consent to the application of state statutes and the County adopted version of the 2020 Model Traffic Code (the “MTC”), as amended by the County, within the incorporated boundaries of the Town of Lake City, a copy of which MTC is attached hereto and incorporated herein by this reference; and

WHEREAS, the Board has determined it is in the best interest of the health, safety, and welfare of the Citizens of the Town to consent to the application of the MTC and State laws within the Town to the greatest extent permitted by law.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LAKE CITY, COLORADO, AS FOLLOWS:

Section 1. The Board of Trustees of the Town of Lake City hereby finds it is in the best interest of the public health, safety, and welfare to consent to the application of State laws and the County adopted version of the 2020 Model Traffic Code (the “MTC”), as amended by the County, within the incorporated town limits of the Town of Lake City, as permitted by Colorado Revised Statutes §§ 30-15-401(2) & (8)..

Section 2. The Town will cooperate with the County to take any and all further steps necessary to permit the County Sheriff to obtain proper authority and jurisdiction to enforce the MTC and State laws within the incorporated municipal boundaries of the Town of Lake City.

Section 3. Severability: If any Article, Section, paragraph, sentence, clause, or phrase of this Resolution is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining portions of this Resolution. The Board of Trustees declares that it would have passed this Resolution and each part or parts thereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.

Section 4. Repeal: Existing Resolutions or parts of Resolutions covering the same matters as embraced in this Resolution are hereby repealed and all Resolutions or parts of Resolutions inconsistent with the provisions of this Resolution are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any Resolution hereby repealed prior to the taking effect of this Resolution.
